New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence of

January 15, 2018 states:

“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Declaration of Grievance

Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment of the United States Constitution

California Governor Removes All Doubt

Naked totalitarianism is always hidden. Its rare indeed when the face of a totalitarian dictator shows itself to the public. For dictators it's a "sizing" issue as in sizing up those you want to control. For Americans its an issue of GOD given rights. Dictators are most comfortable well hidden, in the darkness, well out of the sight of public view coming into view when its time to exert unlawful edicts and commands.

So it is with the naked dictatorship of California's governor who is never seen in public except under the most scripted and controlled circumstances. The governor of California has issued additional executive orders including closures of restaurants, wineries, tasting rooms, movie theaters, family entertainment centers, zoos, museums, cardrooms and bars in 19 counties. The governor exempted Napa County, where he owns the Plumpjack Winery. Plumpjack winery was financed in part by Gordon Getty and Nancy Pelosi.

Even more egregious is the governor is allowing casinos to remain open where there are literally tens of thousands of people daily in California not socially distancing and in close contact with each other while they gamble.

According to Katy Grimes of the California Globe:

“The governor says, “#COVID19 is not going away anytime soon and Californians must adapt to new behaviors to slow the spread.” However, California’s mortality rate attributable to COVID-19 is quite low in a state of 40 million residents, compared to other much smaller states.

But what are the numbers, and why is the governor shutting businesses back down so quickly after they recently re-opened? With testing for COVID-19 going up exponentially, positive tests are also going up, but negative tests are showing up in much higher numbers. Newsom continues to focus on the “surge” and “spike” in positive test results, which according to physicians don’t actually mean that much”.

“While businesses are forced to close again, the governor is also planning on letting another 8,000 inmates out of prison by the end of the month”.

The U.S. Citizens in California are coming to the realization that when the governor refers to “surge” or “spike” he’s referring to the waves of illegal foreign nationals who are co-vid positive that he has invited into California hospitals.

Katy Grimes continues:

“Many in the state are critical of how the governor has used the coronavirus to change society and destroy the state’s economy, all while shredding the Constitution. It is inevitable that this business lockdown has become more and more political when you look at who is controlling politics in California, an Epidemiologist told California Globe. Every Constitutional officer in the state is a Democrat. The Legislature has a super super Democrat majority, and the governor is a Democrat who admitted that he was using the coronavirus to advance the left’s agenda”.

When the Founding Fathers came together to write the constitution they knew that the People with their God Given Rights were responsible for the government and they were very concerned that the People could be compromised by a government in which one of the three branches of government would be more powerful than another thus throwing the entire power balance of the three co-equal branches into a tail spin. The Founders answer was the making of new state found in the “*New State Clause*” of the *U.S. Constitution Article IV, Section 3*. Article IV, Section 3 has only been utilized on three occasions in the formation of all 50 states. The last time Article IV, Section 3 was utilized was at the start of the Civil War in 1861 with the formation of West Virginia.

New California State movement has for over 5 years has been utilizing Article IV, Section 3 to form a new state in direct defiance of the California dictator just like the Founding Fathers had planned. New Californians will **NOT** comply.

The California governor is a pusillanimous craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California while the state continues to operate outside the authorities of the U.S. Constitution violating Articles IV, Section 4, Article VI, the First and Fourth Amendments.
