# **Grievance 43**

November 13, 2018

**New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.**

## **Article IV Section 3 United States Constitution states:**

*New States may be admitted by the Congress into this Union; but no new States shall be formed or erected within the [Jurisdiction](#) of any other State; nor any State be formed by the Junction of two or more States, or parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.*

## **Statement of Intent**

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

*“We are determined to live under a State Government in the United States of America and under the Constitution of the United States”.*

# **New California Declaration of Independence of**

**January 15, 2018 states:**

*“Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.*

*When a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.*

*So it is the history of the past and present Governor and Government of California who have a history of repeated injuries and usurpations, all having in direct Object the establishment of a Tyranny over the Counties of New California and the State of California.*

## **Preamble of the New California State Constitution states:**

*We, the representatives of the undersigned Counties within the State of California, **do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity, seek a republican form of government, protection against foreign invasion and domestic violence guaranteed by Article 4, Section 4 of the United States Constitution, and all privileges and immunities of citizens in the several states guaranteed by Article 4, Section 2 of the United States Constitution, ordain and establish** New California as a fully vested State of the Union of States in the United States of America.*

## **First Amendment of the United States Constitution states:**

**“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.”**

The Counties of New California have brought forward 40 Grievances against the government of California and will bring forward 55 additional Grievances to be announced in public on Tuesday at 11:00 am.

## Declaration of Grievance

### Statement of Facts

The people of California are suffering from a tyrannical communist state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America. All caused by a government of and for a mono party system lead by a tyrannical dictator who openly defies federal law.

### **California State Government is in Direct Violation of the Following:**

United States Constitution Article IV Section 4

***"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."***

United States Constitution Article VI Section 2

***"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."***

## **HUMAN RIGHTS ABUSES**

The communistic mono party government apparatus that has now consolidated its power in California, and which operates outside the limitations of constitutional government with its attendant checks and balances, has subjected the welfare of the citizens and their individual rights to collectivist, communist, and dictatorial totalitarian policies designed to engineer a society that is post-American and that is globalist in loyalty and idealism. This has occurred without a vote and without constitutional deliberation, and indeed, this form of subjection is being forced upon the citizens of California and the structure of this global neo-communist government are being erected in all spheres of civil society controlled by the rogue California government. The values of this system include de-population through vaccines, abortion, elimination of the man-woman marriage, ethnic cleansing, murderous displacement of populations by their removal from rural areas utilizing government orchestrated fire storms, the elimination of private property and individual rights, slavish collectivism, scape goating, bullying, and persecution of those who don't line up with "the party".

We, the citizens of New California support loyalty to the sovereign nation-state of the United States of America and are unwilling to relinquish our citizenship, with its guarantees of individual liberties and replace it with communistic collectivism and its inherent human rights abuses.

## **FRAUDULENT ELECTIONS**

Communist activism, community organizing, and organized crime, combined with the mono party tyranny present throughout the areas under control of the mono party California government have assured that the ballot booth is exercised by non-citizens, felons, and imposters. This is all done with impunity and with the sanctioned protection of the mono party communist apparatus. Despite being well-documented for decades, there has been no effort on the part of the state to secure our ballot booths, verify that imposters do not usurp the vote, and convict offenders of this, our sacred institution, paid for dearly with the blood of patriots and citizens. We, the citizens of New California can no longer submit to fraudulent elections engineered for our own demise. Such an action would be morally repugnant and indeed traitorous. We, the citizens of New California, therefore declare that elections will be conducted in the State of New California with voter authentication and the absence of voter intimidation. To accomplish this end, the independence of the State of New California is morally imperative. Deprived of legitimate representation, independent elections and independent government are the only way for the citizens of New California to exercise their first amendment rights as regards the vote. We, the citizens of New California will not wait for election results to

determine our own destiny. Self-determination and self-governance mandates statehood of the rural counties that comprise the State of New California.

## **Insurrection**

The government of California, the current governor and mono party system along with local officials are following a coordinated design with the intent to actively engage in **acts of insurrection** against the U.S. Constitution.

The **Insurrection Act of 1807** is a [United States federal law](#) that governs the ability of the [President of the United States](#) to deploy [military troops](#) within the [United States](#) to put down [lawlessness insurrection](#), and [rebellion](#).

## **Illegal Acts and Tactics**

Utilizing *Marxist-Leninist* and *Maoist revolutionary tactics* the communist California governor, mono party system and local government officials support and celebrate these tactics as a means to introduce and subvert all aspects of California government and civil society in an attempt to destroy the State of California and breakdown the sovereignty of the Union of States of America.

## **Acts of Secession**

Therefore the California communist government in conjunction with the communist state executive, instituted wherever the current communist governor has usurped power has created a reign of terror on United States Citizens living in California with the intent to **secede** from the United States of America and thus destroy the very **Union of States** which secures our **Liberty and Freedom**.
