Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

“We are determined to live under a State Government in the United States of America and under the Constitution of the United States.”

New California Declaration of Independence

January 15, 2018, states:

“Whenever any Form of Government becomes destructive, it is the Right of the People to alter or to abolish it, and to institute new Government...”

*“...when a long train of abuses and acts to seize and hold the people’s power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **RIGHT**, it is their **DUTY**, to throw off such Government, and to provide new Guards for their future security.*

*“The history of the present Governor and Government of California is a history of repeated injuries and usurpations, all having in direct object the establishment of a **Tyranny** over the Counties of New California and the State of California.”*

Preamble of the New California State Constitution states:

*“We, the representatives of the undersigned Counties within the State of California, **do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....**”*

First Amendment of the United States Constitution states:

“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

Fourth Amendment of the United States Constitution states:

“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”

CONSTITUTIONAL DEFAULT THE NEWSOM INDICTMENT

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America, all caused by a government of and for a mono-party system lead by a tyrannical, pusillanimous dictator who openly defies federal law.

CALIFORNIA STATE VIOLATES:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

United States Constitution First Amendment

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

United States Constitution Fourteenth Amendment

***Section 3.** No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.*

THE NEWSOM INDICTMENT COUNT 1

California Constitution Article I - Declaration of Rights Section 18.

Universal Citation: [CA Constitution art I § 18](#)
SEC. 18.

Treason against the State consists only in levying war against it, adhering to its enemies, or giving them aid and comfort. A person may not be convicted of treason except on the evidence of two witnesses to the same overt act or by confession in open court.

(Sec. 18 added Nov. 5, 1974, by Prop. 7. Res.Ch. 90, 1974.)

COUNT 2

GOVERNMENT CODE - GOV TITLE 2. GOVERNMENT OF THE STATE OF CALIFORNIA [8000 - 22980]

(Title 2 enacted by Stats. 1943, Ch. 134.)

CHAPTER 3. Loyalty [18200- 18200.]

(Heading of Chapter 3 renumbered from Chapter 5 by Stats. 1985, Ch. 794, Sec. 2.)

18200.

A person shall not be knowingly employed by any state agency or court who either directly or indirectly carries on, advocates, teaches, justifies, aids, or abets a program of **sabotage, force and violence, sedition or treason** against the Government of the United States or of this state.

"Any person employed by any state agency or court shall be immediately discharged from his employment when it becomes known to his appointing power that he has, during the period of his employment, committed any such act.

Money appropriated from the treasury shall not be expended to compensate any person whose employment is forbidden by this section".

In January 2021 during an EDD conference call, Julie Su, secretary for the California Labor and Workforce Development Agency said, "Of the 114 billion dollars in unemployment paid by California since March, approximately 10% has been confirmed as fraudulent. An additional 17% of the paid claims have been identified as potentially fraudulent."

That's \$11.4 billion confirmed and as much as \$20 billion more in fraud.

"There is no sugar coating the reality, California did not have sufficient security measures in place to prevent this level of fraud," Su said.

Employment Development Department (EDD) is a department of the state government that administers Unemployment Insurance (UI), Disability Insurance (DI), and Paid Family Leave (PFL) programs. The department also provides employment service programs and collects the state's labor market information and employment data. EDD is one of California's three major taxation agencies, alongside California Department of Tax and Fee Administration and the Franchise Tax Board. In addition to collecting unemployment insurance taxes, the department administers the reporting, collection, and enforcement of the state's personal income taxes.

The Legislature created the Department of Employment as part of the Unemployment Reserves Act in 1935. The act (Statutes 1935, chapter 352) was set up to provide "a (monetary) reserve to assist in protecting the public against the social effects of unemployment." The purpose of the department was to operate a statewide system of employment agencies and distribute the payment of unemployment insurance to eligible unemployed workers.

Under Gavin Newsom's tenure and since the March 4, 2020 covid pandemic announcement the EDD has lost over \$180 billion to fraud. The \$180 billion is an agreed upon number between the federal government and California. But the real numbers are expected to be as high as \$850 billion. Why the large discrepancy between the agreed upon number between the federal and state and outside sources? There were no disbursement controls or audit procedures in place to come up with a *real* number. In 2020, during the COVID-19 pandemic, the system of unemployment benefits was expanded in such a way that it enabled self-employed people to get weekly checks. Few safeguards were in place to prevent ineligible people from getting these checks. This led to massive fraud, reaching around \$300 billion, "perhaps the largest fraud wave in history".

Where did the money go? KCRA reported "*Seventy percent of that money left California. It left this country," Talcove said. "It went to transnational criminal groups that have used that money for nefarious purposes to harm our democracy. Some of that money has been used in sex trafficking, child extortion. I've been actively involved with the National Center for Missing and Exploited Children. And we saw a huge uptick in child trafficking during the pandemic."*

Gavin Newsom (D) failed to disclose he was a client of Silicon Valley Bank as he lobbied the White House and Treasury for a bailout.

Newsom has substantial ties to Silicon Valley Bank through his personal accounts, wineries and his wife Jennifer's charities.

California law [prohibits](#) officials from influencing a government decision in which he or she has a financial interest, according to the Conflict of Interest Codes.

As the investigation into the SVB crash continues there's a growing list of revelations about third party transfers and wire transfers involving China. This leads to Newsom's failed responsibility to supervise the money lost at the Employment Development Department (EDD).

California state is the only state in the Union that does not have audited financials as required by federal law. The last time California had provided auditable financials was June 2020.

There are 58 counties in California. There are 58 County Sheriff's, District Attorney's and Grand Jury's whose jurisdiction these crimes have occurred. Gavin Newsom while governor of the state of California has had direct responsibility to protect these funds and insure the people of California are served and protected. Yet Newsom and his cronies have turned a blind eye to open financial corruption and by doing so have encouraged and engaged in this nations' greatest financial frauds ever that involves nations around the world who seek to destroy the United States.

Its time for full investigations to be conducted by our local county officials and grand jury's. Let there be no doubt Gavin Newsom will be indicted on multiple felony counts.

The State of California is in financial and Article IV, Section 4 Constitutional default and does not have constitutional standing as a member state in the Union of States called the United States of America. **We the People**, as citizens of the United States living in California, are following the process of West Virginia, that successfully restored the Virginia state government after the Wheeling Conventions of 1861. Congress admitted California into the **Compact** of Statehood within the United States of America in 1850 because their 1849 Constitution, ratified for consideration, guaranteed a **republican** form of government.

Gavin Newsom's failure to supervise the EDD has once again demonstrated why there is **no viable government in California** under his watch.

The Newsom Government and all it represents has Seceded from the People of California.

An unconstitutional administrative state now exists in California, in direct violation of the September 9, 1850, *Compact* with the United States of America. The state of California no longer functions as a republican form of government, no longer provides freedom from invasion and domestic violence.

ACTS OF INSURRECTION

The government of California, the current socialist governor/dictator and mono-party system, along with local officials, are following a coordinated design with the intent to actively engage in “*Acts of Insurrection*” against the United States Constitution.

ACTS OF SECESSION
