State of New California NOTICE TO ALL CALIFORNIANS! Chapter II Grievance 16

August 11, 2020

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution.

Statement of Intent

The Citizens of New California have decided to remedy the abuse of power by the government of California by exercising their right to form a new state provided in United States Constitution Article IV Sections 3 and Section 4.

"We are determined to live under a State Government in the United States of America and under the Constitution of the United States."

New California Declaration of Independence of January 15, 2018 states:

"Whenever any Form of Government becomes destructive it is the Right of the People to alter or to abolish it, and to institute new Government.

When a long train of abuses and acts to seize and hold the people's power without legal authority and pursuing invariably the same Object that clearly demonstrates a design to reduce them under absolute Despotism, it is their **Right, it is their Duty**, to throw off such Government, and to provide new Guards for their future security.

Preamble of the New California State Constitution states:

We, the representatives of the undersigned Counties within the State of California, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

The Counties of New California State brought forward 95 Chapter I Grievances between January 2018 and November 2019. On April 28, 2020 New California State will issue 95 additional Chapter II Grievances to be announced in public on Tuesdays at 11:00 am.

Grievance 16

Declaration of Grievance Statement of Facts

The people of California are suffering from a tyrannical state government which fails to provide a republican form of governance, enables and supports across its southern border the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Citizens of America all caused by a government of and for a mono-party system lead by a tyrannical dictator who openly defies federal law.

California State Government is in Direct Violation of the Following:

United States Constitution Article IV Section 4

"The United States shall guarantee to every state in this union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence."

United States Constitution Article VI

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

First Amendment of the United States Constitution

ORDER OF THE DAY \$100.00 PLEASE

Following an amazing series of events New California State has found itself in a never before seen position of driving the truth out of a criminal state government and its governor. New California State during its public conference call on May 13, 2020 announced the state of California was short \$85 billion dollars going into the final financial quarter of 2020. On May 14, 2020 the Legislative Accounting Office (LAO) used the exact same figure of \$85 billion to describe California's cash shortfall for the 4th quarter of 2020. New California State's number was obtained after consultations with the LAO and many hours of extreme research. Let's be clear at the time of the announcement the LAO did NOT have the \$85 billion number until it was announced on the May 13, 2020 New California State public conference call.

New California State declared following the May 13, 2020 announcement the state of California could no longer borrow either short term or long term from lenders because the state was in default of filing their annual 2018-2019 federal FASA report. This comes after months where the *state auditor* had failed to file their legally required monthly audit reports.

New California State then warned on numerous occasions California did not have the cash available to continue the services of state government. California then went and borrowed from its own accounts utilizing a technique they termed from "borrowable resources". A term where the state would borrow money from any means necessary even from federal dollars that were being held in trust for Covid-19 and unemployment purposes known as the *coronavirus relief funds*.

The state of California desperate for cash used the Covid-19 and unemployment funds for some *relief* required by law but not all was used for relief. Virtually all of the federal funds that remained were used for other purposes, purposes that are expressly forbidden by federal law.

Now the cash from the federal government is gone and hundreds of thousands of Californians who were legally qualified for these Covid-19 and unemployment *coronavirus relief funds* have been left empty handed.

On August 8, 2020 President Trump declared at a press conference in Bedminster, NJ. said he will provide \$400 per week in extended benefits, a payroll tax holiday, and eviction protections.

States will have the option of adding more money onto the \$400 federal unemployment extension, Trump said. They can use monies they haven't used for coronavirus battles.

For unemployment, states will be asked to cover 25 percent or \$100 of costs using existing funds through the *coronavirus relief funds*.

During the August 9, 2020 New California State public conference call the details of President Trump's executive orders were discussed and it was immediately recognized that the state of California had already spent the *coronavirus relief funds* and would not be able to provide the cover 25 percent or \$100 of costs in order to make the \$400 required benefits to Californians offered by President Trump's executive orders.

Later on in the evening of August 9, 2020 the CA Department of Public Health Director and State Health Officer announced her resignation. She did not give a reason for her resignation.

On August 10, 2020 the California governor declared that the state could not afford to pay its share of President Donald Trump's new expansion of unemployment benefits because it did not have the money.

From Breitbart, August 10, 2020 Newsom Press Conference:

"Newsom said that providing \$100 per week would cost the state \$700 million per week, rising to nearly \$3 billion if the federal portion of the benefits were to run out of money. He said that the <u>coronavirus aid</u> that had already been given to the state had already been allocated to other spending priorities, and that the state did not have the money to make up the difference.

The state "cannot shoulder this burden without cutting important services," he said. Moreover, he said, paying an additional \$100 weekly benefit through the state's beleaguered unemployment system would also result in "time delays" and "enormous consternation" for people applying for benefits.

It was not clear whether Newsom had shut the door entirely on the expanded unemployment benefits. President Trump <u>said</u> on Sunday that the federal government might be able to fund the entire program".

New California State movement has for over 5 years been utilizing Article IV, Section 3 to form a new state in direct defiance of the California dictator just like the Founding Fathers had planned. *New Californians will NOT comply*.

The California governor is a pusillanimous craven dictator whose words and actions are a grave danger to all U.S. Citizens living in California while the state continues to operate outside the authorities of the U.S. Constitution violating Articles IV, Section 4, Article VI, the First and Fourth Amendments.
